Sportsmanship in League Play

(Found in its entirety on page ii in your player handbook)

"Know the Rules:"

It is every player's responsibility to read and understand the rules. If something does not make sense, ask someone on your team or someone who is knowledgeable and experienced in the game.

"No Sharking:"

"Sharking" is any act designed to upset your opponent or disrupt their concentration at any time during the game.

Examples include:

- ❖ Unnecessary talking to a player down on a shot
- ❖ Making sarcastic comments
- ❖ Refusing to acknowledge an obvious foul
- ❖ Standing close to your opponent's line of vision or
- ❖ Creating sudden noises or movements in line of sight of shooter, I.E., excessive chalking of stick, walking in front of opponents shot.
- ❖ Talking loudly about your opponent to team mates while they are shooting
- ❖ Using profanity

Hello Ladies,

Welcome to our 2nd week of the 2005–2006 WEPLA Season.

In response to this change, the previous schedule that was provided last week is no longer accurate or usable. In order to move forward we, by way of Agnes, have obtained another schedule that will be for 18 weeks, beginning today and this is what we will be going by until the end of the season when another schedule will be created for the last 3 weeks. Thanks Agnes for your assistance with this issue.

I apologize for the inconvenience of these changes, but feel positive that any scheduling errors have now been corrected and look forward to a smooth season.

- Vote on 1st week of play ~ to count or not to count.
- Holiday celebration ~ whether to have a potluck tournament for the league.

The overall team scores to be based on win/loss totals.

The Fundraising meeting held at Juanita's house was very productive. We were a little disappointed with the turn out but because the weather was so bad we decided not to let the low turn out disappoint us. With four teams represented (Missy from the Carousel. & Ann from Flight Deck 2 & Juanita from Al's 1 & Judi from Al's 2) we brainstormed and came up with some pretty good ideas! Here is a brief synopsis of what was discussed:

- Creating shadow boxes of pool tables to be used as raffle prizes, along with two beautiful wall hangings that Juanita is making, and (hopefully) a donated pool cue. There will be tickets made that will list the prizes and the order the prizes will be drawn in. There will also be a flyer with pictures of each item so that they can see what they may win. **EACH TEAM WILL BE EXPECTED TO PARTICIPATE IN THE SELLING OF THE TICKETS FOR THE LEAGUE RAFFLE.**
- Holding a Bake Sale at the Fur Rendezvous Pool Tournament in February of individually wrapped and priced homemade baked goods. We will need people to volunteer to man the table throughout the day and a sign up sheet for times will be forthcoming. We will also need donations of goodies to be sold.
- Sending out a letter asking for cash or prize donations to local businesses throughout the community.
- Holding a swap meet (in the spring) where tables are sold to individuals or vendors and they can bring things to sell/trade/buy. If we can't get this organized in time for this year's season then we may hold a garage sale in the spring.
- Flight Deck has volunteered to let us hold a Spaghetti Feed at their place with us being able to keep all of the proceeds. We thought this was very generous and a great way to make some money but it is going to be a big project and plans need to get underway ASAP.

Individual crafts can be donated (and would be gratefully appreciated) and used for raffle prizes. Volunteers are desperately needed for everything so please contact Juanita at 563-5793 to find out how you can help.

The next fundraising meeting will be held Saturday 12/16/05 at 1:00 pm at Juanita's house at 1611 Dimond Drive in Anchorage. We would like to see at least one person from every team there. If all teams do not participate then we will vote (at the next Captains Meeting) whether the fundraising funds should be given to teams that chose not to participate. We don't want to see it come to this ~ everybody has something they can do to help ~ so encourage someone from your team to come and take part in the next meeting. The more we give, the more we will get out of it.

To make the paperwork flow more easily, please make sure that you fill out the weekly score sheet in its entirety. We need to know who paid (write PD next to each players name), the total amount paid (at the bottom, right hand side of the sheet) the total games won, etc. Thanks! It makes things a lot easier to keep track of.

Last ~ but not least ~ when a team has to forfeit a round (because of a missing player) they are still responsible for paying the full amount (\$40 a team). You can figure it out however you want as a team (splitting the cost, having the missing player pay, whatever) but we are basing the budget on collecting \$40 from each team for each week of play.

This last week we had three teams (Al's 2 / Flight Deck 1 / JJ's #2) so it is an issue that needs to be addressed because it could make a drastic difference in how much money we have at the end of the year to send teams to Vegas.

Thanks to everyone for their positive attitude and competitive spirit. We were very excited about the league taking such a big step forward in membership this year. Each of you has helped to build this up and it is exciting to see such camaraderie between the teams.

Hello Ladies!

In the last couple of memo's we have addressed the issues of "IOU's" not being accepted (*so if you can't pay then you can't play*) along with the fact that checks are strongly discouraged. We also addressed that if a team has a missing player and has to forfeit a round, they are still responsible for paying the full amount (\$40) for the team that week.

Along those same lines ... we ask that no "pre-payments" be made. In other words, don't pay for your weekly dues ahead of time. We are trying to make it easier on those who are keeping track of the payment envelopes. It isn't fair to have them have to figure out who is paying for what and why.

So again, I ask that each team have \$40 (no more and no less) turned in to the treasurer each week and that the captain write paid next to the name of each player (on the score sheet) when they pay their weekly dues.

It was brought to my attention that it would be a "hard ship" on some teams to have to print out their own score sheets each week. So, I have printed out enough score sheets, for each team, to last the rest of the season and RuthAnn has agreed to put one in each of the envelopes every week.

Personally, I don't think it was too much to ask. In order for us to be successful, we need a contribution from each league player to make it work! The fact that we have been able to eliminate most of the running around to drop off and pick up envelopes each week is delightful. Unless you have done it, you have no idea what a hassle it is. We do appreciate all of you contributing to the success of dropping off/picking up your weekly envelopes at Club Oasis each week.
